**SENATE RESOLUTION NO. 145**

WHEREAS, The National Institutes of Health reports that there are nearly 7,000 diseases and conditions that affect fewer than 200,000 Americans, which means that they are considered rare; and

WHEREAS, While each of these diseases may affect small numbers of people, rare diseases as a group affect nearly 30 million Americans, 50% of whom are children; and

WHEREAS, Many rare diseases are serious and debilitating conditions that have a significant impact on the lives of those affected; and

WHEREAS, While the U.S. Food and Drug Administration has approved drugs and biologics for more than 1,000 rare disease indications, millions of Americans have rare diseases for which there is no approved treatment; and

WHEREAS, Individuals and families affected by rare diseases often experience problems, such as diagnosis delay, difficulty finding a medical expert, and a lack of access to treatments or ancillary services; and

WHEREAS, While the public is familiar with some rare diseases, such as muscular dystrophy and amyotrophic lateral sclerosis (Lou Gehrig's disease), and is sympathetic to those affected, many patients and families affected by lesser-known rare diseases bear a large share of the burden of funding research and raising public awareness to support the search for treatments; and

WHEREAS, With nearly one in ten Americans diagnosed with a rare disease, thousands of Illinois residents are among those affected; these people were given a voice in 2017 with the establishment of the Rare Disease Advisory Commission in this State; and

WHEREAS, The Orphan Drug Act has encouraged and promoted the discovery and development of biopharmaceuticals designed to treat and potentially cure rare diseases; and

WHEREAS, Many of the world's leading academic institutions, academic medical centers, biotech companies, and pharmaceutical companies that are conducting research and seeking cures for rare diseases are doing so in this State; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FOURTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare March 5, 2025 as Rare Disease Day in the State of Illinois in order to raise awareness of rare diseases, support individuals and families who struggle with rare diseases, bring attention to the need for research and funding to support the discovery and development of therapies designed to treat and potentially cure rare diseases, and support the continued work of the Illinois Rare Disease Commission; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Illinois Biotechnology Innovation Organization, Chairperson Maria Pollock of the Illinois Rare Disease Commission, and the Department of Public Health.

Chicago's Near North Side; he attended James A. Sexton School; he studied to be a chef at Washburne Trade School before embarking on his career in music; he married Annette Butler in 1959; and

WHEREAS, Jerry Butler achieved fame as a member of the Impressions, who were inducted into the Rock and Roll Hall of Fame in 1991, and later as a solo soul artist; his songs have been sampled by numerous other musicians, including Missy Elliott, Snoop Dogg, Method Man, and The Game; he is a three-time Grammy Award nominee; he chaired the Rhythm & Blues Foundation, which provides a wide range of assistance to musicians and pushed the industry to provide medical and retirement benefits; and

WHEREAS, Jerry Butler had a 32-year political career as a member of the Cook County Board and was the longtime chairman of the powerful Health and Hospitals Committee; while serving on the county board in 1993, he earned a master's degree in public administration from Governors State University; his true passion as a county commissioner was ensuring health care for all, and he was at the forefront in opening John H. Stroger Jr. Hospital of Cook County, replacing the old Cook County Hospital, in 2002; he retired from the county board in 2018; and

WHEREAS, Jerry Butler was preceded in death by his wife, Annette; and

WHEREAS, Jerry Butler is survived by his sons, Anthony and Randy; four grandchildren; and a great-grandchild; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FOURTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare March 12, 2025 as "Jerry Butler Day" in the State of Illinois; and be it further

RESOLVED, That we mourn the passing of Jerry "Iceman" Butler and extend our sincere condolences to his family, friends, and all who knew and loved him; and be it further
